### *Significant Arrest*

**Truancy Sweep-** Officers Laury, Powell, and Waite assisted RPS with a truancy sweep. They apprehended six truants. One truant (15 yoa BM) was on his way to Armstrong H.S., armed with a loaded .22 revolver and several “dime” bags of marijuana, which he told officers he was going to sell after school. He was arrested by Officers Waite and Powell and placed into detention.

**FFI Arrest-** 2100 blk Redd Street, 5/27/10, 1941 hours. Officers Bates and Graham (FFI) observed a vehicle traveling on east Coalter Street with three juveniles not restrained in child safety seats. A traffic stop was initiated and the passenger was found to be in possession of 18 glass vials containing marijuana. The driver gave consent to search her apartment where they both reside.

Numerous empty glass vials and 1 ounce of Marijuana were found. A total of 2 ounces of marijuana was seized and he was charged with felony PWID marijuana.

The victim exited his girlfriend's house and began walking east on Creighton Road. As he was passing a GRTC bus stop he observed a group of individuals sitting on the bench. One of the males pulled out a black handgun and stated "give it up." The other males then began going through the victim's pockets and removed twenty two dollars. The suspects then fled. The victim attempted to follow the suspects to see what direction they were heading. As he did the suspects then turned and began to fire at him. Moments later Officers Kane and Allen arrived. The victim and his girlfriend, pointed out the suspects who began running away. Officers Fields and Esposito arrived and observed the suspects run into a wood line. The suspects then ran out of the wood line and were apprehended. Officers Mary Gary, Eric Allen and A/Sgt. Walter began an extensive search of the area for the firearm. As they were searching a fifth suspect was found hiding in the woods. He was taken into custody without incident. All five individuals were charged with felonies, to included Robbery, Use of a Firearm in the Commission of a Felony, and Attempt Aggravated Assault. The firearm was eventually located.

***Crime Prevention Tips***
